38.1. Warrington Borough Council’s Ranger services

The first few meetings have been positive, with three footpaths being looked at – Dyers Lane, Whiteleggs Lane and Heatley Mere. Sutch Lane is due to be resurfaced this month. Clerk to ask the Environment Team to ensure it stays clear.

38.7. Lymm Parish Council’s Environment Team

A funding application has been submitted for spring bulbs. Staff appraisals have been completed with one officer looking at gathering useful data to share with the public (weight of cleared leaves, number of cleared fly-tipped fridge freezers etc).

Environment Committee **RECOMMENDATION** is for the Parish Council to pay the £97.50 + VAT to the narrowboat owner as a “full and final settlement” with no further recourse to any additional costs. The excess on the policy is £100.

The insurance policy review following the Resources Committee will ensure the correct policy is in place.

40. SLA from Warrington Borough Council for the public convenience at Lymm Dam

Clerk to contact the Warrington Borough Council officer to amend the areas to be covered and the forecast costs. Costs to be brought to the next appropriate meeting.

Key code to be changed regularly.

41. Traffic Sensor Working Group update

RECOMMENDATION: The three remaining devices to be installed at any location around the village, not just the streets detailed in the first phases. The data from the devices can then be considered.

42. Speed Indicator Device (SID) repairs

RECOMMENDATION: To pay the £100 + VAT for repairs for the mobile device. The mobile speed indicator device that records the number of vehicles (not types) and speeds is faulty. An inspection at a cost of £75+VAT has identified that there is £100 + VAT of repairs. This device offers a different purpose to the TELRAAM devices.

- The top yellow border has been snapped off through vandalism
- There is a power connection problem between the batteries and the base unit
- The clamps are no longer tight to the battery terminals
- There is corrosion on all 4 push clamps.

43. Sewage reports

Resident to be contacted about getting in touch with the local press and the MP. Clerk to look for a power to potentially pay for monthly water inspections and source a potential company to carry them out following the sewage leaks in Slitten Brook.

44. Staff Appraisals follow up

RECOMMENDATION: Clerk to manage an annual budget of £500 to replace or repair broken equipment reducing the waiting time for a Council decision.
